Pomo Cultural Study Update

Matters of Commissioners Update

Security Gates – Staff reported that Noyo Boatworks has submitted a bid to build the new security gates, as they have taken over this project recently from Charlie Nelson. Commissioners Bradley and Forkner will meet with Jason and help figure out what is needed.

John Schnaubelt Pontoon Boat on Property by F&W

Staff reported that he spoke to John regarding the pontoon boat he keeps on the property and said he is willing to get it out if necessary. After some discussion, it was decided John can keep it there if he pays \$75/month to the district.

F&W Parking on District Public Parking area

Staff has spoken with F&W regarding the excessive parking on the District public parking area. After some discussion, it was decided to charge them \$300/month for four parking spaces. Harbormaster Pyorre will discuss this with them.
