# REQUEST FOR QUALIFICATIONS FOR AS-NEEDED EXPERIENCE AND EXPERTISE TO DEVELOP THE NOYO HARBOR BLUE ECONOMY VISIONING, RESILIENCY AND IMPLEMENTATION PLAN

#### **PURPOSE**

The purpose of this Request for Qualifications (RFQ) is to provide the City of Fort Bragg with specialized expertise needed to develop the Noyo Harbor Blue Economy Visioning, Resiliency and Implementation Plan, and subsequent Local Coastal Program update. Interested firms and individuals are invited to provide statements of qualifications to provide on-call, as-needed for the services herein. The City intends to select and contract with more than one (1) consultant.

#### **BACKGROUND**

The City of Fort Bragg received an \$898,900 grant award from the California Coastal Commission to support a regional strategy focused on addressing climate change in and around Noyo Harbor through blue economy initiatives. Funds will be utilized to develop the Noyo Harbor Blue Economy Visioning, Resiliency and Implementation Plan, which will include comprehensive baseline information about the existing environmental, physical and economic conditions of the harbor. Specialized knowledge and expertise are needed to support several components of this plan including:

- Site specific analysis of scenarios related to impacts of sea level rise, tsunami hazards, and erosion due to increased wave action;
- Parcel inventory to identify boundaries, current land uses, economic contribution and historic status;
- · Harbor facilities conditions assessment; and
- Aquaculture Feasibility Assessment (including water quality analysis).

#### **SCOPE OF SERVICES**

In connection with the Noyo Harbor planning effort, we are soliciting consultants with experience and expertise in:

- 1. Surveying and mapping, including LiDAR, CAD and/or GIS;
- 2. Civil and hydrological engineering;

- 3. Habitat restoration design, permitting, construction, and monitoring for integrated habitats and multiple benefits;
- 4. Natural and nature-based shoreline protection design;
- 5. Water quality assessment;
- 6. Structural analyses;
- 7. Pre-project feasibility analyses;
- 8. Economic analyses;
- 9. Hazardous or toxic substance investigations;
- 10. Watershed, intertidal and subtidal assessments;
- 11. Archaeological studies;
- 12. Climate change issues such as, species migrations, seasonal coastal and fluvial flooding, and sea-level rise;
- 13. Botanical studies;
- 14. Agricultural studies;
- 15. Soil and marine sediment analyses;
- 16. Site and land use planning;
- 17. Sea-level rise and coastal erosion modeling;
- 18. Environmental monitoring;
- 19. Graphic design for educational materials;
- 20. Traditional Ecological Knowledge;
- 21. Local working waterfront skills;
- 22. Harbor District and Special District Analysis; and
- 23. Other related environmental services, such as appraisals for restoration purposes.

#### **ANALYSIS**

As part of the Noyo Harbor Revitalization Plan, West Business Development Center will be hiring part time staff to fulfill the marine-based entrepreneurial training program and community fish markets deliverable. Since the Harbor District is also in need of a staff, a partnership may be beneficial to both agencies.

Staff could work in the Noyo Harbor District office allowing them to better learn the needs of the fleet for the Revitalization program by working next to the fleet and serving part time in the Harbor Office. West Business also has offices in Fort Bragg and they would be able to work out of that office as well. Ideally staff would be versed in grant project management and act as the grant manger for the Noyo Harbor Revitalization project with guidance from the Harbormaster, Commission and West Business.

West Business and the District office are working on developing a memorandum of understanding that will act as a predecessor for a more formal contract for the Noyo Harbor Revitalization Plan. Including an option to share staffing could be included in the MOU if the Commission directs District staff to continue to investigate this avenue.

#### **FISCAL IMPACT**

Funds for part time staff are already allocated into the Harbor Districts budgets.

**NOAA Marine Debris Grant** 

#### **RECOMMENDED ACTION**

#### **ANALYSIS**

The Harbor District has been invited to apply for the NOAA Marine Debris Grant Program. This program is looking to fund 6 projects nationwide between \$800,000 and \$6,000,000. The focus of this program is the removal and abatement of large abandoned and derelict vessels. The Harbor office submitted a letter of intent to abate 35 documented boats between Somona County, Mendocino County, Humboldt County and Del Norte County public marinas and has been invited to apply for funds. The Harbor office is working with the grant writers from Del Norte County and Sonoma County to complete the application. Alone the Harbor District would not be competitive for this program, partnering with the public marinas to the North and South of us makes us competitive and hopefully creates a more cost-effective program.

The draft budget totaled \$2.9 million and used the top rates the District has seen from contracts in our experiences destroying vessels. The budget also included full time staff for the District for two years to conduct the project and for the District to host an outreach workshop for harbormasters and vessel owners to learn how to avoid abandoning vessels.

#### **FISCAL IMPACT**

This program would be 100% grant funded.

Noyo Harbor District staff includes SHN Engineering who specializes in public works contracts, on staff legal counsel and has extensive experience in abandon vessels as defined by California Harbors and Navigation Code.

Partners for this project include the Crescent City Harbor District, the Humboldt Bay Harbor District, and Sonoma County Regional Parks which operates Spud Point Marina and Mason's Marina in Sonoma County. Harbormaster from each Harbor District will work directly with the Noyo Harbor District harbormaster to successfully complete this project. While this is the first time this group has applied for funds in partnership, they all have worked together previously and are members of the California Port Captains and Harbormasters Association. #### D. Project Location:

This project has brought together all the public agencies that operate harbors in Northern California: Sonoma County Regional Parks, Noyo Harbor District, City of Eureka and Crescent City Harbor District. Together this group of harbors represents 354 miles of the 840-mile California coastline and creates a network of marinas for commercial and recreational boaters. Marine Protected Areas (MPAs) adjacent to the project locations include: Bodega Head SMR and SMCA, MacKerricher SMCA, South Humboldt Bay SMRMA, Samoa SMCA, Castle Rock, and Point St. George Reef Offshore SMCA. Addressing ADVs in the public marinas in this project will help to protect these MPAs from pollutants and impacts of toxic hazardous waste from derelict vessels.

#### E. Project Description:

This project will focus on the removal of abandoned and derelict vessels from within the jurisdiction of each participating harbor. The issue of Abandoned and Derelict Vessels (ADVs) continuously plagues public harbors in Northern California. The method of abandoning the vessel varies from illegally mooring the vessels in marinas, vessels left in slips after the eviction process, and deceased owners with no heirs or estates. Public marinas are then left with the financial burdens of abating the vessels or allowing the vessels to remain in their dilapidated states posing environmental and public health threats. In some cases, the owners can be identified but the majority do not have the financial means to reimburse the harbors for

abatement measures despite legal judgments that are brought against them. For publicly funded marinas there remains no clear-cut solution or path for the abatement of abandoned vessels.

Abandoned vessels are a significant environmental and public health threat. Abandoned vessels often contain unknown amounts of hazardous petroleum products such as gasoline, diesel, motor oil and hydraulic fluids that have the potential to leak into the marine environment. Besides the petroleum threat, abandoned vessels typically include heavy-metal hull paints, mercury, PCBs, asbestos, lead-acid batteries, and other hazardous materials that can enter the marine environment by leaching or as macro-debris. Properly removing and disposing of vessels allows for professional hazardous waste abatement specialists to handle and legally dispose of this waste, removing it from harming our marine resources and coastal communities.

Due to the general nature of vessels that end up as abandoned, many have compromised hulls, leak and in their dilapidated states are dependent on shore power and marina supplied sump pumps to stay afloat. Allowing vessels to remain in the marine environment increases the risk that over time the hulls will deteriorate past the point of no return and the vessel will sink. Vessels that have sunk significantly increase the amount of debris that enters the marine environment. The only solution to mitigate this threat is by removing vessels before they reach this point.

The Noyo Harbor District will be the lead agency on this project and will work with the harbormasters from the partnering harbors to prioritize abandoned and derelict vessels. The Noyo Harbor District will employ legal counsel to ensure all vessels that are abated fall within the California Harbors and Navigation Code's definition of an abandoned vessels and the local jurisdiction has the authority to legally abate. Ideally one contractor will be hired to move between ports and complete the abatement work. To ensure that all hazardous materials are property abated, the Noyo Harbor District will complete hazmat testing prior to abatement.

In addition to taking the lead on removal efforts the Noyo Harbor District will develop outreach for each of the participating ports to inform vessel owners of the negative impacts abandoned vessels pose on the marine environment and provide options to surrender vessels before abandonment occurs. Partnering harbormaster will each spend time on this project managing vessels and conducting outreach to vessel owners to prevent future abandonments within their jurisdictions. The Noyo Harbor District will also host a workshop for all California port captains and harbormasters to develop best practices to prevent abandonment by vessel owners. The workshop will focus on internal harbor policies, enforcement and citation opportunities and best practices in screening potential tenants. The outcomes of the workshop will be presented at a California Association of Harbor Masters & Port Captains meeting. This will allow other ports to be better informed and open a statewide conversation on this topic.

**F. Anticipated Removal Activity Start Date:** Hazmat surveys will begin in October 2024, then there will be a contract bidding period, and physical removals will start in spring 2025.

#### G. Funding:

District is requesting \$2,978,200 to complete this work and will match this program with \$100,000 from the Noyo Harbor District Salvaged and Abandoned Vessel Exchange grant funded via the Department of Boating and Waterways, and staff time of partnering harbormasters in outreach to boat owners.

#### H. Project Outcomes:

The immediate outcome of this project will be the removal of over 30 ADVs from 5 public marinas in Northern California. Crescent City has identified 8 abandoned vessels, Humboldt Bay has identified 5 abandoned vessels, Noyo Harbor District has identified 6 abandoned vessels and Sonoma County Regional Parks has identified 11 abandoned vessels. This will remove an estimated 4,800 cubic yards of debris from the coastal environment and prevent countless gallons of hazardous fluids from entering the local environment.

Long term outcomes of this project will be increased access to public marinas, the removal of threats to public health and safety and reduction of negative environmental impacts from abandoned vessels. The areas in which this project takes place are valuable habitat for NOAA trust resources: marine mammals, fish, migratory birds, and threatened and endangered species live in or near our marinas. Marine debris has acute impacts on local marine economies from fishing to ship services to tourism. Access to slips in public marinas and transit in harbors is often impeded or blocked by abandoned or derelict vessels. The blight of marine debris discourages visitors and recreational uses and may pose bottom or shoreline hazards creating significant liabilities. Abandoned vessels that contain oils and hazardous substances can be presumed to be actively releasing pollutants to the marine environment. Such pollutants are toxic to marine habitats. Marine animals, especially birds, are attracted to marine debris increasing the likelihood of their exposure. By removing abandoned vessels this program expects to improve water quality, expand valuable habitat, and reduce potential risks to public health and safety.

#### I. Diversity, Equity, Inclusion, Justice, and Accessibility Description:

This project also creates equity in low-income communities by removing the financial burden of local jurisdiction to abate abandoned vessels. Noyo Harbor District, Humboldt Bay Harbor District and the Crescent City Harbor District are all surrounded by communities that have been identified as Historically Disadvantaged Communities. In addition, the Humboldt Bay Harbor District and Crescent City Harbor District lie within Federal Opportunity Zones 06023000100 and 06015000102. Being public marinas, Sonoma County Harbors, Noyo Harbor, the Humboldt Bay Harbor District, and the Crescent City Harbor District revenues are dependent on taxes and marina rentals for their operational budget which are often very tight. In order to offset the increase in financial burden of vessel abatement, significant increases to rental rates or local taxes would need to occur. This places an unfair financial burden on already struggling communities.

#### Staff Reports

#### **FEMA Projects**

The District office is still working with FEMA to get projects off the ground. At the last meeting with FEMA it was suggested that the District apply for "A and E" funding. A call has been schedule to walk District staff through that process for Tuesday Jan 9<sup>th</sup>, after the posting of this agenda. A more complete update can be provided in person at the Jan 11<sup>th</sup> meeting.

#### Geveden and Vessel Demo Project

Geveden Industrial has begun work on the vessel destruction project. They have abated two vessels, the Avispa and the Christine. They are currently on budget and on schedule. Overall they have been timely and professional on the job site and the District office is confident that they will complete the project on time and on budget.

An additional vessel may be added to the contracts. Ella, a 35ft wooden boat was surrendered to the Harbor District on Jan 2<sup>nd</sup>, 2024. Ella has recreational CF numbers and is eligible for SAVE grant funding. The District has \$80,000 in unspent SAVE grant funds for the 2023-2024 fiscal years.

#### EDD Contract and Noyo Harbor Revitalization Plan

The EDD has given the Harbor office executed contracts for the Noyo Harbor Revitalization Plan and the District office has reached out to schedule the kick off meetings with the EDD. Harbor Office has also reached out to North Star Ice to schedule meetings to better understand the final cost, timelines and processes for ordering the icehouse. The CSP Ad Hoc and SHN will be involved in the North Start Ice meetings.
